Item	Description
B.1	Approval for the appointment of trustees to serve as representatives to other organizations and board committee members.
D.1	Authority to negotiate and execute agreements with Texas Southern University to provide internship opportunities for student trainers interested in participating in the HISD Athletic Department Internship Program.
D.3	Due to the COVID-19 outbreak and inconsistencies with student outcome data related to disruptions in the normal operation of the district and state accountability system, the Board is asked to waive student performance as a criterion for teacher evaluations under the Teacher Appraisal and Development System (TADS).
D.4	Adoption of recommended instructional materials for pre-k for the 2021–2022 school year.
F.2	Administration is asking the board to adopt a resolution discontinuing the district’s relationship with HISD Student Congress, a student-led organization established in 2014, and creating a new student advisory council. This request stems from tension between the administration and Student Congress.
I.1	Approval of vendor awards greater than \$100,000 and ratify vendor awards under \$100,000.
I.2	Approval of all donations greater than \$5,000.
I.3	Approval of all grant funds greater than \$5,000.
I.4	The board is asked to approve the midyear budget report that contains budget amendments and budget-neutral adjustments between departments.
K.1	The board will consider revisions to its adopted goals to update the goal and constraint progress measures, including adding in baseline data for Goal 3 progress measures. A full outline of the changes is available in the agenda.
